WHEREAS, Commissioner Steinberg wrote a personal check to the City of Miami Beach for a total amount of \$2,250, equivalent to her compensation for the month of May 2020; and

WHEREAS, Mayor Dan Gelber has elected to voluntary forego compensation for the month of May 2020, in the total amount of \$2,769; and

WHEREAS, during March and April of 2020, the accelerating infection rate for COVID-19 led at least 42 states (including Florida), and countless local governments, including Miami-Dade County, to issue orders curtailing mobility, recreational activities, and travel, through "Shelter in Place," "Stay at Home," or "Safer at Home" orders, in order to minimize contact through social distancing measures and reduce the risk of COVID-19 infection, with over 316 million Americans subject to such orders, accounting for over 97% of the country's population; and

WHEREAS, according to the Florida Department of Health, Florida had fewer cases and deaths during the week of April 20, 2020, than it did during the week of April 14, 2020; and

WHEREAS, on April 17, 2020, Jacksonville City and Duval County opened their beaches from 6:00 A.M. to 11:00 A.M., and from 5:00 P.M. to 8:00 P.M. daily with some restrictions, such as prohibiting sunbathing but allowing recreational activities such as swimming, jogging, and biking while adhering to social distancing guidelines; and

WHEREAS, on April 24, 2020 Bay County and Panama City opened their beaches from 6:00 A.M. to 9:00 A.M., and from 5:00 P.M. to 8:00 P.M. daily; and

WHEREAS, on April 27, 2020, Sarasota County opened its beaches subject to social distancing guidelines and certain restrictions – while sunbathing is prohibited, beachgoers are allowed to walk, jog, surf, swim, kayak, paddleboard, and engage in any other recreational activity that can be done while adhering to social distancing guidelines; and

WHEREAS, on April 28, 2020, St. Lucie and Indian River counties opened their beaches subject to social distancing guidelines and restrictions similar to the ones established by Sarasota County; and

WHEREAS, three counties are set to open their beaches on May 1, 2020: Okaloosa County is set to open its beaches from 6:00 A.M. to 9:00 A.M., and from 5:00 P.M. to 8:00 P.M.; Santa Rosa County is set to open its beaches from 2:00 P.M. to 7:00 P.M.; and Gulf County is set to open its beaches from 6:30 A.M. to 9:00 A.M., and from 4:30 P.M. to 7:00 P.M.; and

WHEREAS, limited beach re-opening with restrictions can be one of the first steps and a pathway back to normalcy while being mindful of risks and respectful of limitations, as well as providing some reprieve to Miami Beach residents who, like the rest of the country, have been

impacted immensely during this unprecedented pandemic; and

WHEREAS, as such, the Mayor and City Commission of Miami Beach request Miami-Dade Mayor Carlos Gimenez to re-open public beaches within the City of Miami Beach from 6:00 A.M. to 10:00 A.M., with restrictions and social distancing guidelines in place to ensure that the public adheres to social distancing guidelines; and

WHEREAS, moreover, the Mayor and City Commission further request for Miami-Dade County to allow volunteers to monitor water quality and conduct beach cleanups at any time during the day, conditioned upon the City developing a registry program that would limit volunteer beach cleanups to no more than 10 people at a time, in order to follow social distancing guidelines.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and the City Commission hereby request Miami-Dade County Mayor Gimenez to: (1) re-open public beaches within the City of Miami Beach from 6:00 A.M. to 10:00 A.M., subject to social distancing guidelines, and (2) allow volunteers to monitor water quality and do beach cleanups at any time of the day, conditioned upon the City of Miami Beach establishing a volunteer registration program and implementing procedures to limit gatherings to ten volunteers or less.

### RESOLUTION NO.

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, URGING MIAMI-DADE COUNTY MAYOR GIMENEZ TO AUTHORIZE MUNICIPALITIES TO RE-OPEN POOLS IN MULTI-FAMILY RESIDENTIAL BUILDINGS WITHIN THEIR RESPECTIVE JURISDICTIONS, SUBJECT TO THE SOCIAL DISTANCING REQUIREMENTS OF MIAMI-DADE COUNTY EO 21-20 AND APPLICABLE CDC GUIDELINES.

WHEREAS, during March and April of 2020, the accelerating infection rate for COVID-19 led at least 42 states (including Florida), and countless local governments, including Miami-Dade County and the City of Miami Beach, to issue orders curtailing mobility, recreational activities, and travel, through "Shelter in Place," "Stay at Home," or "Safer at Home" orders, to minimize contact through social distancing measures and reduce the risk of COVID-19 infection, with over 316 million Americans subject to such orders, accounting for over 97% of the country's population; and

WHEREAS, on March 12, 2020, Miami-Dade County Mayor Carlos Gimenez declared a State of Emergency for all of Miami-Dade County due to the threats associated with COVID-19; and

WHEREAS, on March 18, 2020, Mayor Gimenez issued Miami-Dade County Emergency Order ("EO") No. 06-20, ordering the closure of all publicly-owned and privately-owned parks, beaches and recreational facilities in the incorporated and unincorporated areas of Miami-Dade County, to limit the spread of COVID-19; and

WHEREAS, on March 31, 2020, Mayor Gimenez issued EO No. 15-20, ordering the closure of all pools, hot tubs, golf courses, tennis courts, basketball courts, fitness centers, gymnasiums and other common use amenities in multi-family residential buildings; and

WHEREAS, on April 27, 2020, Mayor Gimenez issued EO No. 21-20, ordering the re-opening of parks, golf courses, marinas and boat ramps, subject to social distance requirements, such as the requirement to wear a facial covering and maintain a six-foot distance separation between persons; and

WHEREAS, on April 27, 2020, Mayor Gimenez issued Amendment No. 1 to EO No. 15-20, ordering the re-opening of certain specified amenity areas in multi-family residential buildings, namely tennis courts, golf courses, and basketball courts, subject to the same social distancing requirements of Emergency Order 21-20, but otherwise requiring pools and fitness centers within residential buildings to remain closed; and

WHEREAS, as Miami-Dade County's emergency orders set the minimum standards applicable county-wide, the City can only be stricter than Miami-Dade County, but otherwise the City cannot reopen areas that the County has ordered to remain closed; and

WHEREAS, as of May 5, 2020, all pools within residential buildings remain closed; and

WHEREAS, on April 27, 2020, Palm Beach County issued Palm Beach County Emergency Order No. 5, ordering the opening of community pools consistent with CDC social distancing guidelines; and

WHEREAS, on April 28, 2020, Broward County issued Broward County Emergency Order No. 20-08, ordering the opening, with restrictions, of pools and pool decks located in multi-family housing developments, condominium developments, condominium hotels, or single-family homeowner associations; and

WHEREAS, similar to Broward County's recent steps to re-open pools in multifamily residential buildings, the re-opening of pools in multi-family residential buildings should be prioritized as part of the initial phased re-opening of Miami-Dade County, subject to continued social distancing restrictions consistent with all applicable CDC guidelines; and

WHEREAS, the re-opening of pools and pool decks in Miami-Dade County would provide a much-needed reprieve to residents who would benefit from additional access to outdoor areas where some research indicates the virus is less likely to spread; access to such areas could be implemented safely by condominium associations and property managers, while serving residents' physical and mental well-being; and

WHEREAS, the re-opening of pools and pool decks in multi-family residential buildings would also provide residents with an additional, and safe, option for outdoor recreational use, and would thereby result in fewer residents using recently-opened -- and crowded -- public parks and public recreational areas, thereby facilitating social distancing efforts; and

WHEREAS, if the restrictions in Miami-Dade County EO 15-20 were lifted, condominium associations and building property managers would still retain the ability to close or limit access to their pools and pool decks at their discretion, if doing so is in the best interests of the building and its residents; and

WHEREAS, based on the foregoing, the Mayor and City Commission of Miami Beach urge Miami-Dade Mayor Carlos Gimenez to authorize municipalities to re-open pools in multi-family residential buildings within their jurisdictions, subject to the social distancing requirements of Miami-Dade County EO 21-20 and applicable CDC guidelines.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and the City Commission hereby urge Miami-Dade County Mayor Gimenez to authorize municipalities to re-open pools in multi-family residential buildings within their respective jurisdictions, subject to the social distancing requirements of Miami-Dade County EO 21-20 and applicable CDC guidelines.

**WHEREAS**, the City announced on Monday, May 4, 2020, that South Pointe Park will be closed until further notice; and

WHEREAS, parks are vital for physical fitness and mental wellbeing, and promote mindfulness and creativity, building social capital, reduce stress, increase happiness, and strength mental health; and

WHEREAS, the re-opening of South Pointe Park, which is one of the largest parks in the City, will provide residents with an additional, and safe, option for outdoor recreational use, and would thereby result in fewer residents congregating in the parks that remain open and crowded; and

WHEREAS, the re-opening of South Pointe Park would provide a much-needed reprieve to residents who would benefit from additional access to outdoor areas, where some research indicates the virus is less likely to spread; and

WHEREAS, an April 7, 2020 study, spanning between January 4 and February 11, 2020 across 320 municipalities in China, examined where and how COVID-19 is transmitted and identified only a single outbreak in an outdoor environment, which involved two cases; and

WHEREAS, based on the foregoing, the Mayor and City Commission of Miami direct the City Manager to re-open South Pointe Park, subject to the social distancing requirements of Miami-Dade County EO 21-20 and applicable CDC guidelines.

The city of Tampa has launched a new economic recovery plan that will allow restaurants and retail businesses to expand their outdoor presence without obtaining a permit. Under the plan, named the Lift Up Local Economy Recovery Plan, restaurants and retail stores can legally expand onto public rights-of-way and private parking areas without needing a city permit. A few examples the city gave were parklets and private sidewalks.

Tampa hopes the program will help local businesses expand their capacity, while still meeting Gov. Ron DeSantis' latest order, which allows restaurants and retail stores to open with capacity restrictions.

We want to lift up our local businesses through this recovery and empower them to re-open responsibly," MayorJane Castor said in a statement. "By giving our local business owners as many tools and as much space as possible to safely serve guests, we can work together to protect our workforce, our customers, and our community. Our small businesses are the backbone of our economy, and we need their help to safely and successfully re-open our city and get back to all the things we love--one step at a time."

Under the program, restaurants will be under certain restrictions including:

- Limiting indoor capacity to 25 percent
- Spacing seating at least 6 feet apart
- Using disposable paper menus
- Providing hand washing stations for customers and employees.
- Requiring facial coverings must be worn by "front of house" employees who interact with customers

Dear Mr. Morales:

First, I want to thank you, the Mayor, and City Commission for your leadership during this unprecedented global pandemic. As a hospitality operator in the City of Miami Beach, I appreciate your commitment to making thoughtful, yet difficult, decisions to safeguard the public's health and the City's finances.

While I believe most of the actions taken by our City government have been measured, fair, and reasonable, I believe the absolute prohibition on hotel operations – even for Essential Lodgers and First Responders – is unduly restrictive and inconsistent with best practices.

Almost every significant government body in the region – including Miami-Dade County, Broward County, Palm Beach County, City of Miami, City of Coral Gables, City of Ft. Lauderdale, City of West Palm Beach, etc. – has strictly limited hotel operations however allowed them to remain open to *"Essential Lodgers,"* defined in Miami-Dade County Emergency Order 09-20 to include first responders, healthcare professionals, and patients' families, among other categories. This is consistent with similar, carefully-calibrated measures implemented in major cities throughout the country.

Miami Beach's absolute prohibition on lodging operations is simultaneously putting into jeopardy the survival of local businesses and hurting Essential Lodgers, especially those working on the Beach. Hence, I am respectfully requesting that you modify the City's Emergency Order to allow Essential Lodgers to stay on Miami Beach. You can take extra precautions to protect the public's health and ensure compliance with the rules. For example, you can:

- Require participating operators to submit a COVID-19 Operations Plan to understand the precautionary measures adopted by each operator (Sonder is ideally positioned to operate under the current circumstances as our buildings/units are equipped with keypad-entry technology, and serviced through mobile apps, meaning no in-person interaction with between guests and employees is necessary).
- Monitor reservation requests and audit any operator's compliance of bookings with Essential Lodger requirement. (Sonder has implemented a screening process that requires each potential guest to qualify as an Essential Lodger pursuant the

definition of MDC Emergency Order 09-20 prior to confirming their booking. Outside of Miami Beach, we are screening out more than 50% of incoming reservation requests due to this restriction.).

• Begin by allowing hospitality operators to *accept bookings only for apartmentstyle units with fully-equipped kitchens*, thus enabling Essential Lodgers to remain in their units when not fulfilling their essential functions (Sonder manages 53 such units in Miami Beach with fully-equipped kitchens and in-unit washer/dryers)

I urge you to consider the experiences of other major cities and, at a minimum, allow uniquely-situated operators like Sonder to keep our doors open and serve our community. I wish you the best of luck as you continue to navigate the City through this challenging time.

#### **MIAMI-DADE COUNTY EMERGENCY ORDER 09-20**

WHEREAS, section 252.38(3)(a), Florida Statutes, gives political subdivisions the authority to declare and enact a State of Local Emergency for a period of up to seven days, thereby waiving the procedures and formalities otherwise required of the political subdivision by law; and

WHEREAS, on March 1, 2020, the Governor of Florida issued Executive Order Number 20-51, directing the State Health Officer and Surgeon General to declare a Public Health Emergency due to the discovery of COVID-19/novel Coronavirus in Florida; and

WHEREAS, on March 9, 2020, the Governor of Florida issued Executive Order Number 20-52, declaring a State of Emergency for the state of Florida related to COVID-19/novel Coronavirus; and

WHEREAS, on March 12, 2020, the County Mayor declared a State of Emergency for all of Miami-Dade County; and

WHEREAS, COVID-19/novel Coronavirus poses a health risk to Miami-Dade County residents, particularly elderly residents and those who are immunosuppressed or otherwise have high-risk medical conditions; and

WHEREAS, minimization of contact is necessary to avoid risk of COVID-19 infection for the residents of the County; and

WHEREAS, the Centers for Disease Control (CDC) has issued guidance entitled "15 Days to Slow the Spread," encouraging social distancing and maintaining a 6 foot separation between residents to slow the spread of infection and that events with more than ten attendees either be cancelled or held virtually; and

WHEREAS, the CDC guidelines are based upon the amount of community spread within a community and become more stringent where there is minimal to moderate or substantial community spread; and

WHEREAS, numerous persons have congregated in Miami-Dade County for spring break and other social activities, and are congregating in and around hotels without observing the social distancing guidelines as recommended by the CDC; and

WHEREAS, it is in the best interests of Miami-Dade County to prevent crowds of people inside and around hotels, as COVID-19 continues to spread through both the local community and throughout the nation; and

WHEREAS, hotels, motels, and short-term vacation rentals and other commercial lodging establishments may serve as shelters or housing options for healthcare professionals, first responders, national guard members, law enforcement, state or federal government employees, airline crewmembers, other essential personnel, patients, patients' families, journalists, and others responding to the COVID-19 emergency, or displaced residents or visitors, persons unable to return to their home due to exigent circumstances, such as fire or flood, persons utilizing hotels as transitional living arrangements, persons sheltering in hotels due to domestic violence, hotel employees, service providers and contractors, or individuals, who, for any reason, are temporarily unable to reside in their home; and

WHEREAS, some Miami-Dade County residents rely on hotels and motels for weekly and monthly long-term living arrangements and the closure of commercial lodging establishments would negatively affect their living arrangements; and

WHEREAS, section 252.46, Florida Statutes, directs local governments to act consistent with Federal recommendations in responding to emergency situations; and

WHEREAS, sections 8B-7(2)(e) and (o) of the Code of Miami-Dade County ("Code") authorize the County Mayor to limit the movement of persons inside Miami-Dade County in order to safeguard life and health,

THEREFORE, as County Mayor of Miami-Dade County, I hereby order:

1. To aid the availability of hotel rooms for (1) healthcare professionals, (2) first responders, (3) National Guard members, (4) law enforcement, (5) state or federal government employees, (6) airline crewmembers, (7) patients, (8) patients' families, (9) journalists, (10) others responding to COVID-19, (11) displaced residents or visitors, (12) persons unable to return their home due to COVID-19 impacts on travel, (13) persons who must vacate their homes due to exigent circumstances, such as fire or flood, (14) persons utilizing hotels as transitional living arrangements, (15) persons sheltering in hotels due to domestic violence, (16) hotel employees, service providers, and contractors, or (17) individuals who, for any reason, are temporarily unable to reside in their home ("Essential Lodgers"), the following restrictions shall apply to commercial lodging establishments:

- (a) Hotels, motels, and other commercial lodging establishments shall not accept new reservations for persons other than Essential Lodgers.
- (b) Hotels, motels, and other commercial lodging establishments may accept reservations for new Essential Lodgers.

2. Notwithstanding section 33-28(D)(3) of the Code, the maximum daytime and overnight occupancy for short-term vacation rentals shall be up to a maximum of two persons per bedroom

plus two additional persons per property not to exceed a maximum of ten persons. New rental agreements shall not be entered into on a nightly or weekly basis, effective March 23, 2020.

3. The provisions of this order shall serve as minimum standards. Municipalities may impose more stringent standards within their jurisdictions.

4. This order shall be effective immediately.

5. The County Mayor may amend the provisions of paragraphs 1 or 2 by written notice to the County Clerk.

6. This order shall expire upon the expiration of the existing Miami-Dade County State of Local Emergency, except that if such State of Local Emergency is extended, this order shall also be deemed to extend for the duration of such extension. This order may be cancelled earlier by action of the County Mayor.

7. This order shall be provided to all appropriate media consistent with the requirements of section 8B-7(2)(n) of the Code.
